An overall trend analysis shows Part I Offenses are down nearly 8 percent from last year; and Part II Offenses are down 8.5 percent from last year. Part III, IV & V Offenses (Calls for Service) have remained steady with negligible change from last year. Motor Vehicle Accidents have decreased by a percentage point.

I will never act officiously or permit personal feelings, prejudices, animosities or friendships to influence my decisions. With no compromise for crime, with relentless prosecution of criminals, I will enforce the law courteously and appropriately without fear or favor, malice or ill will, never employ unnecessary force or violence and never accepting gratuities.

I will recognize the badge of my office as a symbol of public faith and I accept it as a public trust to be held so long as I am true to the ethics of the police service. UNIFORMED PATROL DIVISION

The objectives of the Uniformed Patrol Division are as follows:

1. **PROTECTION OF LIFE AND PROPERTY:**

Citizens expect the patrol officers to protect their lives and property from crime and disaster, using safe practices and procedures.

2. **PREVENTION OF CRIME:**

A uniformed officer in a marked squad helps deter crime before it starts.

3. **ENFORCEMENT OF LAWS:**

A patrol officer must know his/her duties and responsibilities. He/she is frequently called upon to make on the spot decisions and take immediate enforcement actions.

4. **PRESERVATION OF PEACE:**

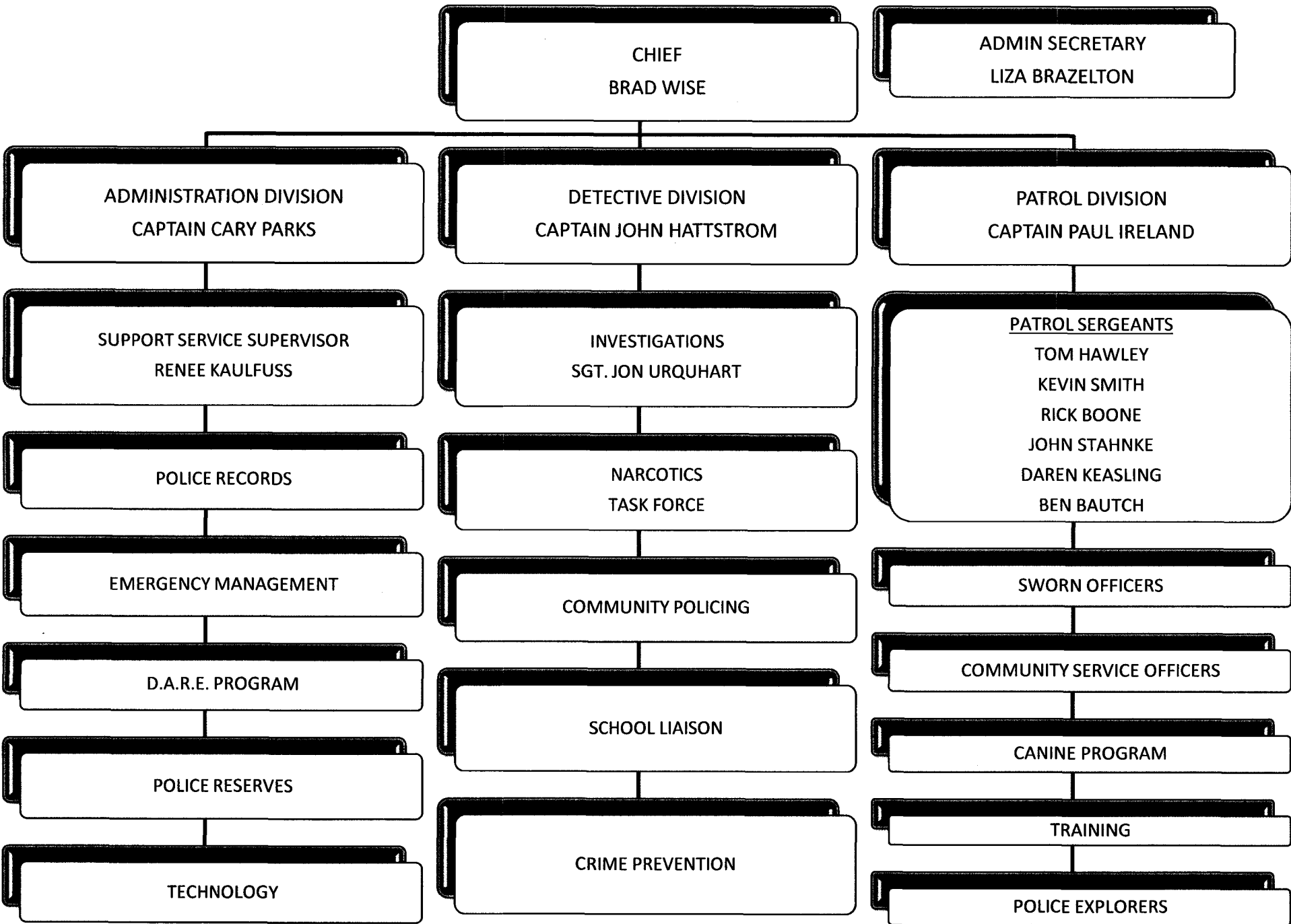
Some of the patrol officer's time is spent in handling domestic situations, drunk and disorderly persons, crimes of violence, trespassers and related crimes.

5. **APPREHENSION OF CRIMINALS:**

A patrol officer observing a crime or ordinance violations must determine whether the offender should be physically arrested or only cited into court. He/she must also decide what specific charges will be placed against the offender.

6. **AIDS TO THE PUBLIC:**

The patrol officer is expected to render reasonable assistance to members of the public in need of help.

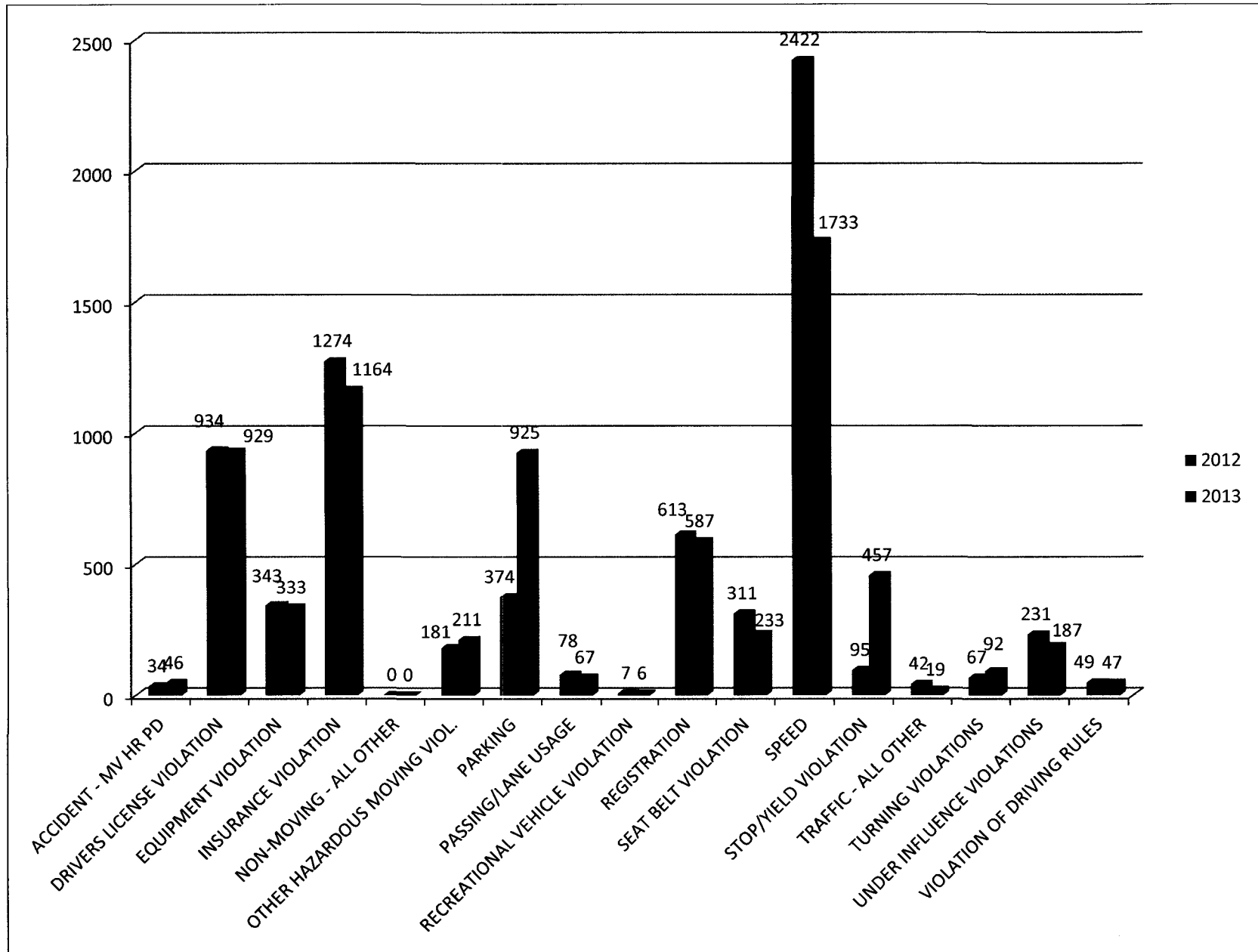

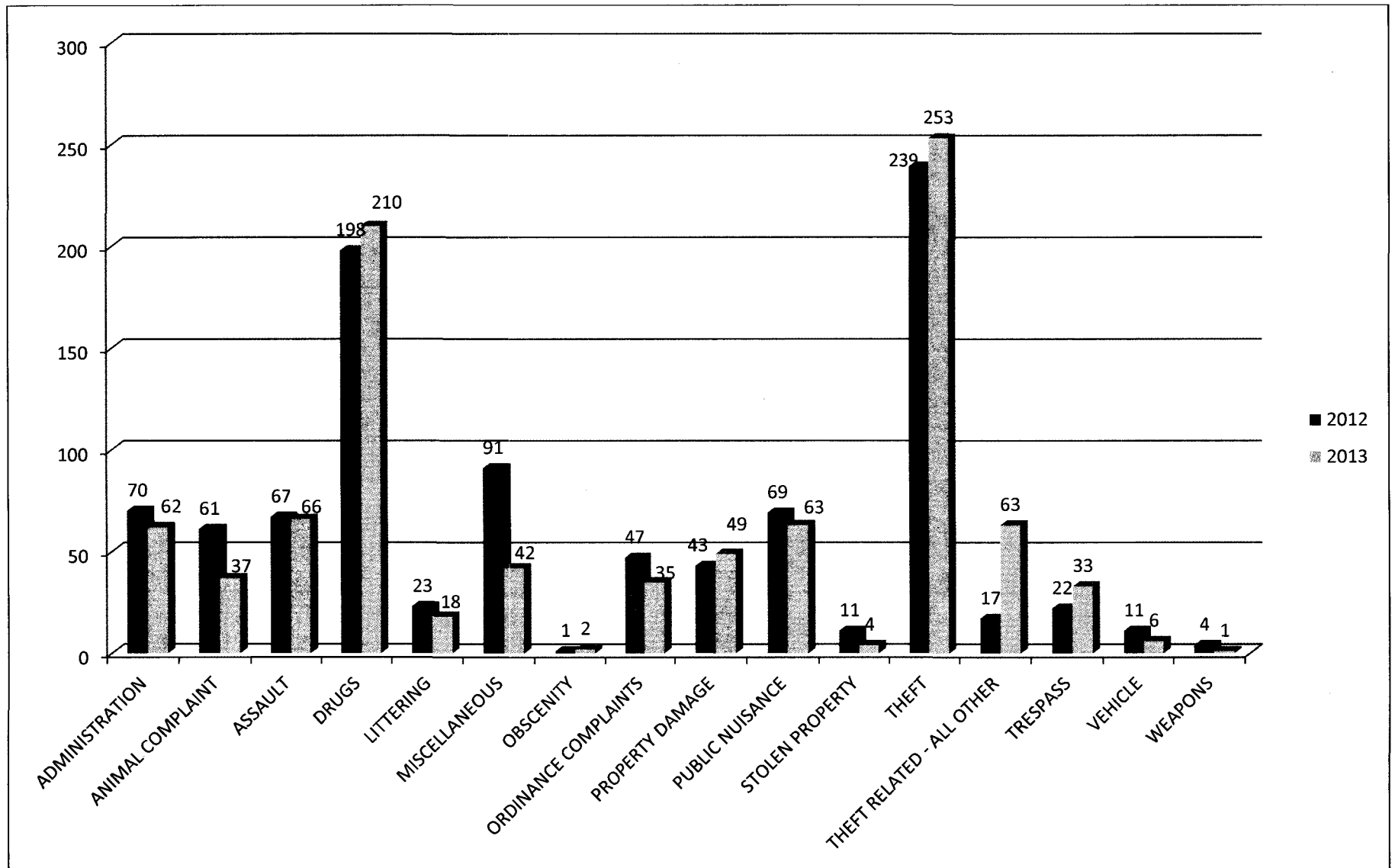
